When they carrying out the work in accordance with the law, their status in the system is parallel to each other, no one can be replaced.

Based on the contents of governance, social governance can be divided into broad sense and narrow sense of the social governance. Mainly include the protection of cultural diversity, promote cultural fusion, reshaping the culture, social values, equality, justice and free content creation, the rule of law. The fourth is the ecological treatment system. This is to maintain the basic guarantee of people and natural harmony, including save resources, to curb pollution, protect the ecological diversity etc.. Those five part constitute the main framework of governance and social governance in general and the operation system, as the elements of social governance system interaction, interdependence, mutual promotion, mutual restraint, to promote the progress of the national development and human society. While we advocate for of today's social governance, more focus on the social and public life, including the promotion of social justice, the norms of social order, guide social organizations etc..

2. THE SOCIAL ORGANIZATION IS AN IMPORTANT PART OF SOCIAL GOVERNANCE SYSTEM

2.1 The Social Governance Need Social Supervision System

Among them: the main function of decision system is processing the information around social governance objectives, analysis, formulate feasible scheme and evaluation, scheme selection and decision, coordination and control of the whole process, and the formation of the final decision; The main function of the implementation system is to accurately perform the decision-making, implementation of the goals and tasks of decision making; The main function of supervisory control system is to supervise the implementation of the decision of the executive system, and the evaluation on the implementation of the decision feedback to the decision system, promoting the decision system update decision, at the same time, according to the implementation of the decision of punishment suggestion.

2.2 Social Organizations to Participate in the Social Governance Through Monitoring System

According to the feature of service organizations, whether profit or non-profit, to a certain extent there is information asymmetry phenomenon with the government who are authorized to exercise the functions of social governance, in order to protect their own interests or the interests of the public, social organizations will have this or that kind of contact behavior of government, building a fair and equitable social environment, social supervision system play an important role, and social organizations can also play a supervisory role. Therefore, the social organization is an important part of the social management system and supervision system, the parallel mechanism of social governance is a process to achieve the use of the power restriction and supervision of government. Decision making system of social organizations in social governance, undertakes the supervision and restraint system for the implementation of social governance responsibilities. Therefore, the emergence and development of social organizations in the source inclusiveness and transparency in governance, social governance goals determine the direction of development of social organizations, social organizations to participate in social governance level and ability should change with the change of social governance tasks, focus and ways of social organization, plays an irreplaceable role in the social governance system.

Finally, the establishments of accountability framework effectively, improve the openness, transparency, the authority of the accountability system, to promote the social accountability mechanism construction.
